Food- Naomi reached out to a local catering company. They prefer if they are the only food truck, Naomi expressed her concern about them being the only food truck. They are not commenting about sharing revenues and she has not heard from them. May be a dead end.

Larry and Lloyd's Weiner wagon could be an option.

With one truck, could be massive line ups. Could be better with multiple trucks. Would be best for us to have at least two trucks to avoid this.
