1. Registration and RTR - We are still having registrations come in which is good news and we have a couple swimmers doing a 2 week trial. We also have several assessments upcoming.

2. RTR is completely up to date. Swim Canada announced yesterday that they are introducing a new Registration system - Very much hoping that it is easier to use than the current system and doesn't muddy the water further. For next year - goal is to have registration open early in the summer and be a bit more streamline and simple.

3. Team Communication: Newsletter for March/April went out last week.

4. Social Media - Instagram followers up to 508 and engagement continues to be high. Will recommend to promote a few ads over the summer, and to get assessment and registration dates published

Profit & Loss Commentary

• Received the \$1.5k grant from the Town of Collingwood to support the June Meet

- The In-Kind grant from the Town of Collingwood will cover the cost of the pool/lifeguards during the June Meet
- Meet fees from the June Invitational should bring in approximately \$23k.
- Bank balance will increase on June 1st. Canada's Wonderland cost several thousand dollars and there are Meet fees from May. All will be charged to accounts on June 1st.
- Proposed increase in fees for Bronze & Novice for next season discussion for future recommendation prior to Registration Set Up (approx. 4-5 weeks away)

Awards Banquet and AGM

The Board has set a date of June 8th for the Awards Banquet. The AGM will be held at the same time while the older swimmers supervise younger swimmers outside on the playground (weather permitting). Banquet will be a Potluck and Rebecca will send out assignments to Members.

Board Positions for Re-Election

A communication will be sent to Members in accordance with the Policies and Procedures regarding the nomination process. Positions available include President, Secretary, Officials Coordinator, and Meet Manager.

Practice Schedules/Membership Dues next season

The Board reviewed the need for further discussion on Membership Dues for next season. The new practice schedule will include additional in-water time for Bronze and Novice. Those Dues will need to be reassessed.

Coach Travel & Meals Expenses

The Board reviewed the idea of an Athlete Surcharge for Away Meets to help cover the cost of Coaching Travel and Meals while away. Ian to review the budget prior to the next discussion.

CCSC Code of Conduct Updates

The Board reviewed a recent situation and agreed that there is a need to update the CCSC Code of Conduct requirements that includes Athlete and Parent conduct. We have received a copy of the Code of Conduct from Barrie Trojans which is much more in depth and details what steps will be taken should a violation occur. Board will reassess this topic after the June Invitational.
