Acceptance of the Agenda for 2019 DST AGM as written: **moved** by Danielle, **seconded** by David V **CARRIED** 

1. <u>Minutes of the last Annual General Meeting adopted as written</u>: **moved** by David V, **seconded** by Janice **CARRIED** 

2. <u>Business arising from the 2018 minutes:</u> discussion last year regarding the new volunteer and officiating bonds and requirements – team will be continuing the same program for both. Cheques due Nov 1 2019 dated for Mar 1 2020

3. <u>Financial statements and proposed budget for next ensuing year</u>: reviewed the draft year-end financial statements (posted online at duncanswimteam.com) Leanne clarified the appearance of not balancing but really just a timing issue with respect to the purchase of the starting blocks in 2017/18 and borrowing money from 2018/19 followed by the facility purchasing over a 4 year term. Budget was updated from last year but follows the same revenue and expenditure streams. Notes from Bookkeeper on the Annual Report:

•Accounts Receivable is estimated outstanding fees from FY 2018-2019

•Does there remain a need to hold \$10K "equipment purchase reserve", on paper, for fixed asset purchases? This was originally intended for scoreboard enhancements and blocks.

•2018 Grant Receivable \$18K was received October 2018 from BC Games Society

•Restricted Gaming Funds is exactly what is on hand at August 31 2019 in the Gaming account.

•Gaming Revenue recognized on the income statement for FY 2018-2019 is lower than amount received June 2018 as \$15K of the \$32K for 2018-2019 was consumed in FY 2017-2018

•Cash Flow report included

•Surplus prior year, deficit current year appears to be due to multiple factors, decline in monthly fees and related revenue and timing of expenses, particularly pool cost expenses.

Facility shut down planned for May/June will not be known until end of January/early February. As soon as she knows, the membership will be informed and a plan for training will be devised. Review of the performance of the swimmers this past year – percentage wise was the highest performing group ever. Congratulations swimmers!

Reminder that it takes 55 volunteers to run the meet day of. Lastly, Orange and Black meets count towards the session requirements with the expectation that those more experienced officials will mentor those just learning.

# Notes to Financials Duncan Swim Team Society

# Year ended August 31 2020

- Revenue generation and pool rentals terminated March 19 2020
- BC Gaming Grants should be averaged between the 2019 and 2020 year
- CEWS 75% Wage Subsidy is a federal government program for Covid-19 relief
- These funds were receivable at year end August 31 and received in September
- Sponsorship receivable is the four year program with the Pool assuming ownership of the blocks. Each of the four years, there is a \$5,000 reduction to pool rental fees recorded.
- Federal Government Loan CEBA \$40,000 is the federal government no interest loan as part of the COvid-19 relief measures. Loan repayment will begin January 2021. The balance owing at Dec 31<sup>st</sup> 2020 will determine the amount forgiven, up to a maximum of 25% or \$10,000.


## Background:


The Duncan Swim Team (DST) is evolving and changing. Our goal is to become a society with a "Policy Board" model of governance, with decision making by paid staff assisted by a volunteer Board. The Board will consist up to 6 members: the Executive Officers (President, Secretary and Treasurer) and Directors (Administrative Director, Technical Director, and Director at Large). The day-to-day operation and decision making will be made by paid staff as directed by the Administrative and Technical Directors using Board resolutions as a mandate and guideline. The Director at Large is intended to be a previous member or honorary member of the organization.

This model is intended to remove much of the decision making from volunteers and to increase the organization's focus on long-term planning and success of the DST. The Board will allow the day-to-day operations of the Society/Swim Team to be run by the paid staff, both coaching and administrative components, and using paid staff and volunteer members, which will allow the Board to focus on policies to support the growth of the organization.

The Administrative Director and Technical Director positions will be filled by senior coaches.
