### **\*Important\* Before Registration Opens**

All swimmers must have completed an in-pool assessment by FAST prior to registration or have a report card from a previous session within 12 months of the registration date.

**Before you can register, your FAST account must be confirmed/validated.**

1. You will receive an email no later than Tuesday, June 11 asking you to confirm/validate and update your FAST account
2. Please update all information including emergency contacts and any medical information
3. If this is not completed by Tuesday, the system will not allow you to register on Wednesday at 8:00 am

### Schedule & Term

Summer 2024 Session runs from **June 17-July 21, 2024**

**\*NOTE\* due to facility scheduling, week one of the summer session is different than the remaining weeks**

### Summer 2024 Schedule

All groups will practice 3 times each week. Blue group swimmers practice 3 times and have 1 dryland class each week

## Clothing/Gear

- A coloured latex swim cap will be given to your swimmer on their first day of practice (replacement caps cost \$10 each)
- Any one-piece swimsuit is fine (does not have to be the FAST team suit until they start competitive swimming)
- At least 1 pair of goggles is required. You can purchase your own, or we sell Speedo Jr. Vanquishers in our online store for a special rate
- Many swimmers like to wear flip flops on the pool deck
- All other clothing or merchandise is optional

## Respect in Sport (RIS) Certification – \*required\*

- RIS certification must be current (not expired) as of June 15<sup>th</sup>, 2024
- Swimming Canada has a **5-year recertification requirement**. Most of you have already completed this requirement last year and will not have to renew it until your 5<sup>th</sup> year is up
- **Log into your RIS account to see if your certification has expired (certification date must be before June 15, 2019)**
- If you do not have this certification or it has expired, FAST requires at least one parent/guardian for each swimmer family to complete the **Respect in Sport** for Parents online course – before your swimmer will be permitted to participate in FAST activities
- This is a 60 min online course and will cost you \$12/parent certification
- **Transferable from other sports if you have already completed it. Must still log into your RIS account and select “Import your certificate” to Swimming Canada affiliate**
- Once you complete the course, our Office will receive notification automatically but please keep a copy of your certification in case there is a problem. Please choose Swimming Canada as your affiliated club. [Click here to register](#).

## Online Registration and Waivers

When you register your swimmer using our online platform, you will be asked to agree to a number of waivers and releases including:

1. Medical & Liability Release
2. Photo Release
3. Code of Conduct – please read

There is one (1) additional waivers that need to be completed before your swimmer can participate in any FAST activity:

1. SNB's Acknowledgement & Assumption of Risk – must be electronically signed once you receive an email from Swimming Canada (about 1 week after registering) asking you to update your account information

## Refund Policy

You will have 5 days after the session starts to request a refund of registration fees. All refunds are subject to a \$25 cancellation fee; insurance fee and pool fund fee are non-refundable).

**No refunds will be given after the 5<sup>th</sup> day of the session**

## Fundraising

## Registration Checklist

- Pre-Register on June 10, 2024, general registration opens on Wed, June 12, 2024
- Check your [RIS Certification](#) is current, if it isn't or you don't have it, complete the online program by June 15. If you have it through another sport, go to the link and request to transfer a copy to Swimming Canada/FAST
- Ensure payment upon registration
  - Email Transfer to [fastswimmingoffice@gmail.com](mailto:fastswimmingoffice@gmail.com)
  - If using credit card, ensure your card number has been added to your FAST account. Credit Card payments will be charged automatically, or
  - sign up for [Pre-Authorized Debit](#) and your payment will be automatically. If you are already signed up for PAD payments, you do not have to re-submit this form,
- Understand:
  - No refunds will be given after the 5<sup>th</sup> day of the session
  - a \$25 late fee will be charged for payments received after their due date or returned payments
  - a \$25 cancellation fee applies to all cancellations
  - All parents, swimmers, volunteers, officers must abide by our Code of Conduct
