

Consent, Waiver, Indemnity and Release

RED DEER CATALINA SWIM CLUB (“RDCSC”) wishes to promote itself, and to celebrate and publicize the achievements of RDCSC and its swimmers. We seek your consent to record your child by photograph and video, and to use your child’s name and image in Media.

I also waive any right to royalties or other compensation for the use of such photographs and/or videos.
