- The disputed charge from last September (a mistake) is now fixed. - Got GST form to file taxes. Will get budget number to file GST return from the club bookkeeper .

- TD to Vancity Transition update: 4 signing officers, ordered checks, outstanding checks on TD that should be cleared soon, TD will stay open until all checks are cleared out.

- GIC options: treasurer recommends we put most of the GIC money (\$15,000) in a non-redeemable 12 month GIC, and the balance in a cashable GIC with a

 $30\ {\rm day}$  lockout. We will investigate further before making a final decision.

- Registrar. We are at 49, and not 50, due to an injury; we will have a new trial swimmer soon. We should be up to 50 soon.
- Secretary. Added Katie's link on the website. Working on adding meets to the website.
- Head Coach. All coaches are back for another term and the most up to date schedule is on the calendar.
